The approval is valid for two years from the date of issue of this letter. The INSTITUTE OF EXCELLENCE IN MGT. SCIENCE PLOT NOS. 129-132, TARIHAL INDUSTRIAL AREA OPP.- TELEPHONE EXCHANGE, TARIHAL HUBLI - 580026 KARNATAKA shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/ Admission Authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. In case the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfillment of following conditions:

1. That the management shall provide adequate funds for development of land and building and for providing related infrastructural, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
2. (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
(b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
(c) That the admissions to the courses shall be made only after the affiliating University / State Board has given permission to start the course.
