The institute offers a 2-year full-time MBA program that is approved by AICTE and affiliated with Karnataka University, Dharwad. Admissions are conducted in accordance with the guidelines set by AICTE and Karnataka University. According to state government regulations, 50% of the seats are allocated under the Government Quota, while the remaining 50% are reserved for the Management Quota. If any seats in the Government Quota remain unfilled in a given academic year, those vacant seats will be filled under the Management Quota. The admission process adheres to state government guidelines concerning the admission of students from various reserved categories
